## Google Analytics Alternatives

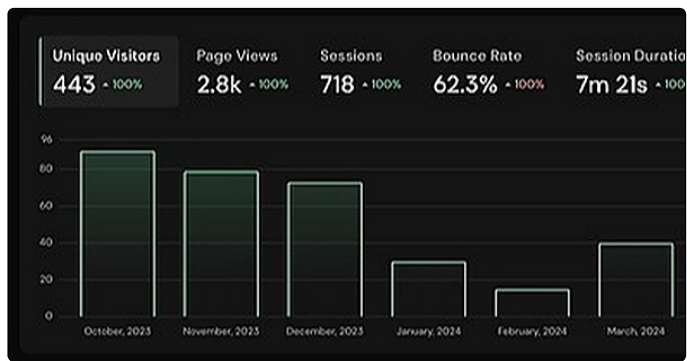

Sweden has even issued the first significant fine of €1 million for using Google Analytics. In the search for Google Analytics alternatives, I have found some solutions that work, and I am sharing them here.

Reasons to Choose Alternatives Over Google Analytics:

- **Owned by Google:** Largest ad-tech company, leading to privacy concerns.
- **Bloated Script:** Affects site speed and performance.
- **Overkill:** Too complex for most site owners' needs.
- **Privacy Liability:** Complicated compliance with GDPR, CCPA, etc.
- **Cookie Consent:** Requires user consent to store cookies.
- **Inaccurate Data:** Blocked by many plugins and browsers.
- **Extensive Privacy Policy:** Demands a detailed privacy policy.
- **Referral Spam:** Data can be skewed by spam.
- **Proprietary Product:** Trust issues with Google's data handling.
- **User Experience:** Necessitates annoying consent prompts.

## Pirsch.io - a german alternative to GA

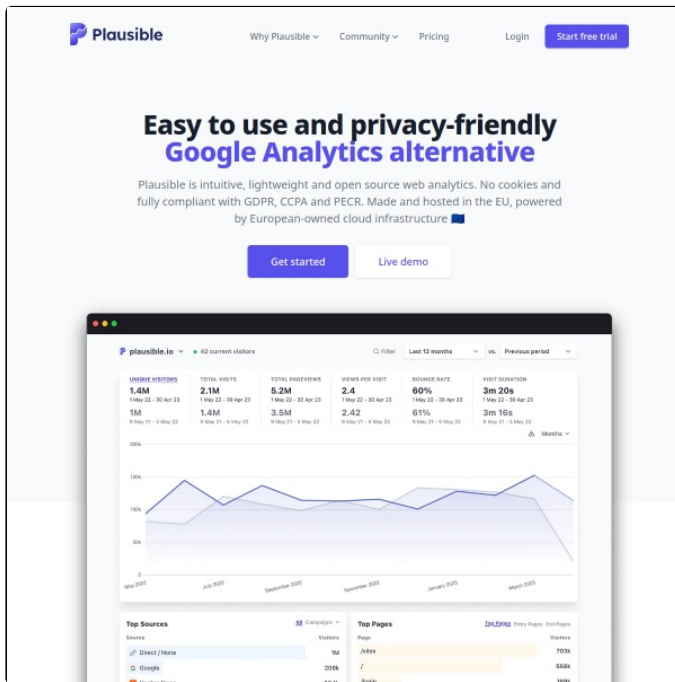

## Plausible.io – open source solution from Estonia

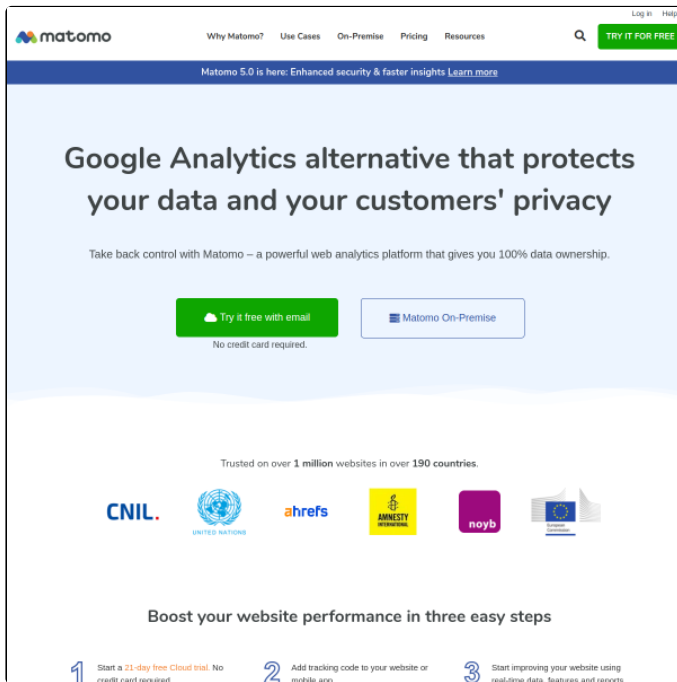
